FURTHER TO THE NOTICE DATED 14 FEBRUARY 2023, NOTICE IS HEREBY GIVEN to the Noteholders that the Issuer has executed a deed of novation, amendment and termination whereby Mars Capital Finance Limited has been appointed to the roles of Mortgage Administrator and Legal Title-Holder under the Mortgage Administration Agreement, and each other Transaction Document to which the Mortgage Administrator and/or the Legal Title-Holder (as applicable) is a party, in place of Kensington Mortgage Company Limited (the "**Deed of Novation, Amendment and Termination**").

The Deed of Novation, Amendment and Termination was executed on 20 February 2023, and therefore the retirement of Kensington Mortgage Company Limited as Mortgage Administrator, and the appointment of Mars Capital Finance Limited as replacement Mortgage Administrator, became effective on such date. The notice period requirements in the Mortgage Administration Agreement relating to the resignation of the Mortgage Administrator and Legal Title-Holder were waived by all parties to the Mortgage Administration Agreement.

It is expected that the effective date of the retirement of Kensington Mortgage Company Limited as Legal Title-Holder and the appointment of Mars Capital Finance Limited as replacement Legal Title-Holder will occur on or around on 20 February 2023.
